

## Rules and conditions of the prize game

### 1. Article

### 2. Article

Adults with permanent or temporary residence in the Slovenia, Croatia or Hungary can participate in the prize draw.

Minors (under the age of 18) must have the prior written consent of their parents or legal guardians to participate in the prize draw.

Employees and external contractors of the organizer or their immediate family members may not participate in the prize draw.

#### 6. Article

#### 7. Article

The organizer reserves the right to refuse participant in the prize game or to exclude it from the prize contest in case of incomplete or untrue information.

The organizer does not take any responsibility for any errors that may occur when providing incorrect or false information by the participant in the prize game.

#### 8. Article

The winner will receive the prize at the Grosbasket store in Ljubljana, Zagreb or Budapest.

The organizer informs the winner by written invitation about the method of receiving the prize.

If the winner does not accept the prize within thirty days after the announcement of the winners, he loses the right to the prize without the right to any compensation.

## 9. Article

## 10. Article

In case of providing incomplete, incorrect or untrue information and in case of reasonable doubt about the false or duplicate Instagram profile of the participant, the organizer reserves the right not to award the participant.

The organizer do not take any responsibility for any errors that may occur when providing incorrect or false information by participants in the prize game.

## 11. Article

By accepting the prize, the winner agrees to the processing of personal data for the purpose of submitting the relevant taxes.. The advance payment of personal income tax is calculated and paid by the organizer of the prize game.

## 12. Article

The organizer undertakes to pay all taxes on prizes (including VAT). The organizer deducts the advance payment of personal income tax from the value of the prize in accordance with the applicable regulations and sends the winner a certificate of the value of the prize for personal income tax return.

## 13. Article

The winner must pay any additional personal income tax payments on the basis of the annual personal income tax. The advance payment of personal income tax is not deducted for prizes up to 42 EUR and is not included in the tax base of the recipient. Even for the value of the prize up to 42 EUR, the winner is obliged to provide the organizer with a tax number.

#### 14. Article

In case of unforeseen circumstances, the organizer may suspend or end the prize draw without prior notice.

In the event that the organizer in an individual case find any kind of abuse in the prize game, the organizer will exclude such a participant from participation in the prize game.

#### 15. Article
